-Rules-

1. Registration: Send registration form to Levon Matthews at Waccamaw High School, 2419 Kings River Rd. Pawleys Island, S.C. 29585

3. Blastoff is at 7:00am. "Or sage light" ( Rain or Shine)
4. Limit: 2 bass per boat with a 12" minimum and 2 redfish per boat with 15-23" measured on golden rule.
5. Equipment: Artificial lures only. No rods over 8 ft. in length
6. Winner: Will be determined by most pounds of fish for the Largemouth Bass division and Redfish division per boat.
7. Big Fish: The largest bass and redfish in creel. Only one (1) big fish for each division per boat is eligible.
8. Ties: Will be broken by largest fish in creel. Further ties broken by flip of coin.
9. Dead Fish: .25 lbs. per fish will be removed from the total weight and will become property of Waccamaw Hawg Hunters.
- 10. Live Fish: Every effort should be made to keep fish alive by use of properly aerated live well. All live fish will be released.**
11. All fish must be landed from your boat.
12. No fishing with within 25 yards of another boat.
13. Legal Fishing Area: All waters must be reached by boat (no trailering is allowed). Ditches or water ways that are locked are illegal ad off limits to all participants.
14. Weigh In: Any boats returning after 1:00pm will be penalized by one (1) pound, and then team is disqualified after 1:05pm. Disabled boats must be towed to be eligible. Fish may be sent by another contestant providing one partner accompanies their catch,
15. Reckless Driving: Will not be tolerated, team will be disqualified.
16. Protest: Protests must be presented within ten minutes after the weigh-ins have been completed, and in writing to the Tournament director. Competitors found accusing others of violation of rules without formally filling protest may be charged with unsportsmanlike conduct and disqualified from tournaments as well as future tournaments of Waccamaw Hawg Hunters.
