Each year, the Barnwell Soil and Water Conservation District awards a farmer or landowner for outstanding conservation efforts. On February 26, 2015, the District recognized a farmer for conserving soil and reducing runoff by strip-till planting all row crops.

Nutrient and pest management practices are utilized on his farm including variable rate application of fertilizer and lime. He also plants winter cover crops to improve soil quality. All of these practices have crop production and environmental benefits.

For his dedication to farming and natural resource conservation, Commissioner Mike Sullivan presented a plaque to Robbie Wood as the District's 2014 Conservation Farmer of the Year for Barnwell County.

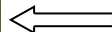

## Conservation Practices

Shown below are some of the conservation practices being utilized by farmers and landowners in Barnwell County. Conservation practices protect the environment by enhancing our natural resources including soil, water, air, plants and animals. The USDA-Natural Resources Conservation Service assists with the planning and application of these practices and offers financial assistance through conservation programs.

In partnership between NRCS and the Barnwell Soil and Water Conservation District, the District provides administrative support to complete conservation program contracts. During the past 5 years, these conservation programs have helped farmers and landowners install practices on 41,997 acres in Barnwell County. The contracts obligated \$4,915,107.00 to partially cover the cost of these practices.



**Cover crop** residue can suppress weed germination and growth while maintaining soil moisture during periods of drought. Cover crops also reduce soil erosion & water runoff while improving soil quality.



**Cross fencing** allows livestock grazing to be rotated between different sections of pasture. This controlled grazing system improves the health of the forage producing pasture while increasing the percentage of forage that is actually consumed by the livestock.



The installation of **firebreaks**, which typically requires land clearing and grading, protects woodland from wildfire. It also allows for the management of a prescribed burn.



**Strip-till planting** row crops, such as peanuts planted into corn residue, saves time, labor, and energy. Like cover crops, this also reduces soil erosion and water runoff while improving soil quality.





**Watering tanks** provide clean drinking water for livestock and are a critical part of a well-managed grazing system. The **crushed limestone pad** eliminates mud and standing water.



**Longleaf pines** planted on chemically treated clear cut forest land provide timber production. Also, longleaf pine forests represent some of the world's most biologically diverse ecosystems.



Old center pivot and traveling gun irrigation systems are being replaced by new low pressure center pivot systems with **mid elevation spray application (MESA)**, commonly known as drop nozzles. These new systems have much better water application efficiency. This conserves water and energy.

**The District assisted NRCS with 163 USDA Farm Bill Program contracts that provide financial assistance for farmers and landowners to complete conservation practices.**
