SC Department of Natural Resources 2012 Public Drawing Turkey Hunt Belfast Wildlife Management Area

Applications must be post-marked by Wednesday, February 29, 2012 to be eligible for the drawing. Mail applications to Belfast WMA Turkey Hunt, PO Box 167, Columbia, SC 29202. Hand delivered applications must be delivered by the deadline date. This office will conduct the drawing one week after the deadline date. Any application received with the correct post-mark after the one week time period will not be considered in the drawing. The SCDNR is not responsible for lost or misrouted mail.

1. HUNT DRAWING: There will be two adult turkey hunts and three youth only turkey hunts scheduled this year. For the youth only turkey hunts, only the youth (17 or younger) are allowed to harvest a turkey during the hunt. Adults are expected to be actively involved in the hunt but are not permitted to harvest a turkey.
2. CUSTOMER ID # INFORMATION: Your customer ID number on your hunting license either begins with the letter C (Example: C10004239) or is identified as Customer Number 10004239. Your customer ID number is NOT your hunting license number. If you hold a Gratis License, Lifetime License, are under 16 years of age or if you are unsure of your customer ID number, please provide your social security number.
3. LICENSE REQUIREMENTS: Each successful applicant must have a Wildlife Management Area Permit and a Big Game Permit in addition to a valid Hunting License to attend the hunt. A hunter younger than 16 years of age is not required to have a hunting license, but must be accompanied by an adult 21 years of age or older. (NOTE: Applicants under age 16 are only required to possess turkey tags.) Statewide turkey regulations will be enforced.
4. HUNT FEE: A fee deposit of \$20.00 per group must accompany the application. Make check or money order payable to SCDNR. Should the check of an applicant be returned by the bank, there will be a \$25.00 service charge. If your application is unsuccessful in the drawing, hunt and permit fees will automatically be refunded.
5. WMA PERMIT: All successful applicants must possess a WMA permit. A temporary \$5.50 WMA Permit, good only for this hunt, is available only to SC residents and only at the time of application. If selected, the notification slip indicates the \$5.50 WMA Permit is included. A \$5.50 temporary WMA Permit is not needed if you possess a Sportsman License, Junior Sportsmans License, a Disability License, a regular WMA Permit, a Gratis (Over 64) License or are under the age of 16. (Nonresidents are not eligible for temporary WMA Permit.)
6. HUNT SITES & AND DATES: Applicants may apply for either the adult hunt dates or the youth only hunt dates, but not both
7. HUNT INFORMATION: Applicants who are drawn will receive complete hunt information on their notification. There will be a limit of 1 gobbler per hunter. Only youth may harvest turkeys on youth only hunts. Hunting will last until 11:00 a.m. on the date drawn. Drawn applicants must present notifications at the hunt site.
8. CANCELLATIONS: Once drawn, cancellations will not be refunded. Successful applicants should contact the Columbia office if they are unable to attend. Cancelled slots will be filled by random selection of applicants who were not drawn. There are no transfers!
9. DUPLICATE APPLICANTS: A person may apply only once for all the turkey hunts at Belfast WMA. You cannot apply for both the adult turkey hunts and the youth only turkey hunts. All applications including the name of a duplicate applicant will be disqualified from the drawing if duplicates are received.
