In order to utilize the Internet Point of Sale system you MUST have:

- **A computer at your place of business with internet access which includes dial-up, DSL or high speed cable.**
- **The computer must have a Windows operating system of XP or 2000.**

Thank you for your interest in selling hunting and fishing licenses for the S.C. Department of Natural Resources. In order to qualify to be a license sales agent the following must be met.

1. You must have been in business at your current location for 6 months prior to the date of your application,
2. You must currently stock hunting and/or fishing supplies.
3. You must be open daily and readily accessible to the general public and have standard hours of operation/ not a part-time business.
4. You must have a secure place to store money.
5. You must have adequate space to post information signs at the place of business.
6. You must agree to purchase a security bond annually.
7. Must maintain a yearly license sale of \$300.00 to retain license selling privileges.

All paper license agents will be required to transition to the new POS system by July 1, 2009.

Point of sale agents will be drafted twice a month on the 1st and 15th. The first insufficient funds - the account will be deactivated immediately. The agent will then be allowed to make payment in full, and the account reactivated. The second insufficient funds - the agent will lose his license privileges for 1 full year and be given ten days to make the balance current, before a bond is processed. The agent will then have to reapply and be reevaluated to determine whether license privileges will be reinstated.
