

# LIFETIME RECREATIONAL HUNTING AND FISHING LICENSE APPLICATION

Lifetime Licenses are only available to South Carolina residents. For the purpose of applying for a Lifetime License "resident" means any person who is a citizen of the United States and who has been a domiciled (permanent) resident of the state of South Carolina for a period of 180 consecutive days or more immediately prior to the date of application for license. **A legible photocopy of a South Carolina driver's license or South Carolina Identification Card must accompany this application.** (Ownership of property or payment of property taxes or both does not necessarily constitute residency.)
