- I. Call to Order

Questioned the need for a new method for reporting litter incidents and hot spots?
 - o Robert McCullough—do we need to modify and beef up the existing program and not create a new program?
 - Allen Hutto—how is the model currently working and are there areas for improvement?

- Resolution made to remove the section on Tip411 from page 13 and to reassess the Litter Busters Hotline discussion to include future cross promotion.
- Need to look into re-establishing #LB or something similar with current mobile companies. Historically had a line with companies such as Altel, but they no longer exist.
- Tigerron Wells requested corrections to page 14 to amend the number 47 to 46 counties.
- Ike Gray requested corrections to page 11 to amend the number of litter crews from 22 to 24 and 195 total inmates.
- Any additional changes must be submitted to Valerie Shannon no later than November 7, 2016 to ensure report is finalized, printed and distributed by November 15, 2016 deadline.
