**I. Call to Order**

The meeting was called to order by Robert H. Boyles, Jr., at 10:08 am. Chairman Boyles introduced himself as Interim Chair and asked each member for a brief introduction as well.

**II. Approval of minutes**

Chairman Boyles asked if there were any additions, deletions or corrections to the November 29, 2018 meeting minutes. A. Hutto made a motion to approve the minutes; T. Wells seconded the motion and the motion carried unanimously.

V. Shannon presented the Community Service blueprint: a step-by-step process for agencies to find people for community service. Aiken County is highlighted as the champion for utilizing the judicial system in finding individuals for community service.

S. Lyles presented the Adopt-A-Road documentation to help highlight how they successfully established the program in in Aiken and Dorchester counties.

T. Wells suggested inviting the Solicitor’s Office to the table for input.

T. Khon suggested a best practices package to be made available to the state and dedicated Litter Commission website.

J. Rhodes spoke about looking at possible legislation to tighten regulations concerning covered loads and improper covered loads. Horry & Greenville counties are good examples of combating the issue.

R. McCullough presented the South Carolina Wildlife magazine which covered the story on litter and what is being done about it. T. Wells recommended legislators should receive a copy of the issue to highlight the efforts of combating litter.

Chairman Boyles suggested creating an ad hoc committee for the best practices guide. A. Hutto offered to chair the committee - S. Lyles, T. Khon, D. Parker and J. Nelson agreed to be on the committee. The motion was accepted to create the Best Practices ad hoc committee
