2020-2021 Waterfowl Season Report

Overview of Hatchery Infrastructure

Ross Self, Chief of Fisheries, gave an overview of SCDNR's hatchery infrastructure and improvements that need to be made to each hatchery.

WMA Sunday Hunting Update

Emily Cope, Deputy Director of Wildlife and Freshwater Fisheries, provided an update on Sunday hunting: SCDNR is partnering with Clemson University to poll user groups and gather opinions and information on the topic. The report is due August 1, 2021.

Legislative Update

Emily Cope presented legislative updates that included blue catfish limits, shooting areas for pen raised mallards, non-game fishing devices, live transport of swine, and a proposed expanded year-long trapping season.
